night on June 17th at Castle Air Museum in Atwater at 6:00 p.m. It was National Police Week three weeks ago and it was National Peace Officer Memorial Day on May 15th. He advised that Congressman Duarte voted for the bipartisan Improving Law Enforcement Officer Safety and Wellness Through Data Act.

Johanna Torres thanked Council for the proclamations that recognized two communities. She mentioned the Pride Event that the Madera Coalition For Community Justice will be holding. Ms. Torres asked that Council consider financially supporting a historic safe space.

A member of the community stated that the NAACP, along with the Madera County Arts Council, is sponsoring an art exhibit on June 13^{th} from 5:00 p.m. -7:00 p.m.
