# E-1 City Council Discussion of Options Regarding the Process for Filling of a Potential Vacancy on the City Council

**Recommendation:** Discussion and direction from Council as appropriate.

(Note: The Elections Code has strict timelines regarding filling of vacancies. However, elections results are not anticipated to be certified by the County until just before the Council meeting, and well after Agenda is published. As a result, it is unknown at this time if a vacancy may be created or not. To preserve all options for the Council, this item is included on the Agenda as a placeholder and may be removed if not warranted.) (Report by Shannon Chaffin)

Victor Montes, a County resident stated that having an election for a person who is only going to serve for one year would be a waste of resources.

No further Public Comment was presented. Public Comment was closed.

Mayor Pro Tem Rodriguez nominated Rohi Zacharia and Councilmember Evans seconded.

Mayor Gallegos nominated Tim Riche and Councilmember Montes seconded.

Councilmember Mejia would like the public to be able to get information through the City social media, etc.

Mayor Gallegos opened public comment.

A citizen of District 1 asked if there was a process where a representative of District 1 to be involved in the nomination. City Attorney Shannon Chaffin stated that only the City Council can make appointments, however they can establish groups to make recommendations to the Council, however due to time constraints, that would be difficult to accomplish.

Member of public, asked that for transparency purposes, the public have an open period to respond if they are interested.

No further Public Comment was presented. Public Comment was closed.

ON MOTION BY MAYOR GALLEGOS AND SECONDED BY COUNCILMEMBER EVANS THERE ARE TWO (2) NOMINEES, NOMINATIONS ARE CLOSED, NOMINEES ARE ASKED TO ATTEND THE DECEMBER 18<sup>TH</sup> COUNCIL MEETING FOR AN INTERVIEW AND COUNCIL RESERVES ITS AUTHORITY TO CONSIDER OTHER NOMINATIONS IF THE MAJORITY OF COUNCIL AGREE. MOTION WAS APPROVED BY A 5/1 VOTE. NAY: COUNCILMEMBER MEJIA. VACANT: DISTRICT 1

After discussion, City Manager Arnoldo Rodriguez summarized that the expectation is that nominees will submit a written response by December 11<sup>th</sup> which will be public and will be included in the meeting packet for the December 18<sup>th</sup> Council meeting. At the December 18<sup>th</sup> Council meeting, the nominees will have a maximum of five (5) minutes to introduce themselves and then the City Council will conduct the interviews and ask them questions. All interviews will be public record and will take place during the December 18<sup>th</sup> Council meeting inside the Council Chamber.

Mayor Pro Tem Rodriguez stated that if needed during the December 18<sup>th</sup> meeting and if Council agrees, those interested in being considered for nomination may submit a resume and interview at that time.

Mayor Pro Tem Rodriguez requested a review of the member selection process for the Airport Advisory Committee, including a discussion of alternative methods for selecting members. This request stems from the committee's inability to meet due to a lack of quorum, preventing any business from being conducted. Mayor Gallegos noted that the Council voted 5/1 to place this item on a future agenda, with one councilmember voting in opposition.

Mayor Pro Tem Rodriguez congratulated his colleagues on their election/re-election. He is honored to serve on the Council for the next four (4) years.

Councilmember Mejia congratulated her colleagues on their election/re-election. She thanked all the candidates who had the courage to run for office. She looks forward to tomorrow's Candlelight Parade.

Mayor Gallegos thanked everyone for attending. She looks forward to moving the Council with positive leadership. She stated that the Candlelight Parade starts at 6:00 p.m.
