# **POWERS, DUTIES, & FUNCTIONS**


The Madera Police Department is a full service law enforcement agency consisting of sworn officers and professional staff employees. The Chief of Police is directly accountable to the City Manager and directs the operation and administration of the agency. The department is responsible for:

- Preservation of the public peace;
- Protection of the rights of all persons and property;
- Prevention of crime:
- Detection and arrest of offenders;
- Enforcement of violations of state laws and city ordinances;
- Building partnerships with citizens;
- Proactive patrols to deter criminal activity;
- Traffic enforcement and education to reduce crashes;
- Provide superior service.

The department covers 20 square miles with a population of 68,598 residents. The city is divided into four beats. Our patrol officers work 12 hour shifts, which includes a day and night shift. Each shift is staffed with one Sergeant, one Corporal and a minimum of five officers.

# **PATROL DIVISION**

The Patrol Division is the largest and most dynamic unit within the Madera Police Department, entrusted with a broad spectrum of responsibilities to ensure the safety and well-being of the community. This division operates with four teams, each working 12-hour shifts to provide comprehensive coverage across the city. Each team is led by a dedicated sergeant and corporal, with a minimum of five officers.

Patrol responds promptly to a wide array of incidents, including traditional law enforcement calls such as vehicle collisions, thefts, robberies, violent crimes, fires, noise complaints, persons in distress, and missing persons. As the first line of response, the division plays a pivotal role in addressing immediate community needs and fostering public safety.

Every officer in the Patrol Division is committed to delivering superior service and maintaining the trust placed in them by the citizens of Madera. They fully embrace the significant responsibility of safeguarding the community and approach their duties with professionalism, integrity, and accountability.

The Patrol Division takes great pride in the trust and confidence of the community it serves, striving to exceed expectations and perform at the highest standards every day.





## **COMMUNICATIONS CENTER**

The Communications Center serves as the vital hub of the Madera Police Department, ensuring seamless coordination and timely responses to community needs. In 2024, the center handled a total of 121,140 emergency and non-emergency calls from residents within the City of Madera, including 27,647 9-1-1 calls. Each call is carefully assessed to dispatch the appropriate personnel based on the situation at hand.

Equipped with three dedicated 9-1-1 lines and six non-emergency lines, the Communications Center efficiently manages the volume and variety of calls. With a single touch, calls can be transferred to surrounding jurisdictions to ensure swift responses across boundaries.

Dispatchers communicate with officers via police radio, keeping meticulous track of their status using the Computer Aided Dispatch (CAD) system. This system also monitors the activities of Animal Control, Code Enforcement, and Parking Enforcement officers, ensuring a coordinated approach to public safety and service.

The Communications Center is a cornerstone of the department's operations, demonstrating a steadfast commitment to connecting the community with the critical services they depend on.

In 2024, the Police Department handled 65,073 events, which include calls for service from the community (e.g., crimes, public safety concerns) and officer-initiated activities, such as vehicle stops and pedestrian checks. Calls for service can result in a report being filed, an area being checked, an arrest being made, or simply a discussion with a citizen.

We are committed to providing prompt and superior service to the community, aiming to maintain the lowest possible response times to calls for service. When a call is received, it is categorized based on its priority and immediate need. Calls are classified into three categories:

- Emergency: Code 3, "Lights & Siren" response, such as a report of a man with a gun, a traffic collision with injuries, or a medical emergency.
- Priority 1: High priority, such as a domestic disturbance, a missing child, or a fight in progress.
- Priority 2: Urgent calls, such as a disturbance or a non-injury traffic collision.
- Priority 3: Non-urgent calls involving incidents that have occurred and the suspect is no longer on scene and with no immediate need for an officer, such as vandalism that occurred the day before.

The response times shown in the chart are measured from the moment the call is received by our dispatcher to the time the officer arrives at the scene.

# INVESTIGATIONS

The Investigations Unit of the Madera Police Department is led by Sergeant Matthew McCombs, who oversees a dedicated team that includes Detectives Reynard Camp, Jacob Dunn, Dina Santos, Priscilla Ramirez, Marco Martinez, Cody Luginbill, and Crime Analyst Lacy Burleson. In 2024, the unit managed a total of 447 cases, showcasing their commitment to addressing complex and serious crimes within the City of Madera.

The Investigations Unit is tasked with handling all felony cases reported in the city. These cases encompass a wide range of crimes, including homicides, assaults, sexual assaults, robberies, missing persons, and fraud. Each case is assigned to a Detective, who is responsible for conducting a thorough and aggressive investigation to ensure justice is served.

Detectives work closely with the District Attorney's Office to build strong cases for prosecution, with the ultimate goal of holding offenders accountable. The unit takes immense pride in providing closure to victims and ensuring the safety and well-being of the Madera community.

Through their dedication and professionalism, the Investigations Unit plays a vital role in upholding the department's mission to protect and serve the citizens of Madera.

# SPECIAL INVESTIGATIONS UNIT (SIU)

The Special Investigations Unit (SIU) is a collaborative, multi-agency task force dedicated to reducing crime, fear, and disorder in the City of Madera through proactive policing strategies. Comprised of members from the Madera Police Department, Madera County Sheriff's Office, and Madera County Probation Department, SIU brings together diverse expertise to address complex criminal issues.

The team primarily focuses on gang-related crimes, high-risk offenders, drug trafficking, and stolen vehicles. As a valuable resource to the Patrol Division, SIU takes on cases and issues that are too extensive or complex for routine patrol operations. Additionally, the unit analyzes crime statistics and trends to implement targeted enforcement operations aimed at suppressing violence and addressing recurring crimes such as burglaries and thefts.

By focusing on these critical areas, SIU strives to minimize crime and enhance the overall quality of life for Madera's residents. Through teamwork and dedication, the Special Investigations Unit plays a pivotal role in creating a safer and more secure community.



## TRAFFIC DIVISION

Traffic safety continues to be a top priority for the Madera Police Department. Our goal is to enhance community safety through a combination of traffic education and enforcement. In 2024, our Traffic Division was staffed by one full-time Sergeant, three traffic officers, and a part-time Downtown Parking Enforcement Officer. The division focuses its efforts on high-priority areas such as school zones, speeding, and impaired driving enforcement.

In 2024, we increased our personnel dedicated to traffic enforcement, leading to a significant rise in traffic stops. Officers conducted 7,667 traffic stops in 2023, and 10,121 in 2024. This increase in enforcement efforts is helping to improve safety through both education and strict adherence to traffic laws.

One of our major initiatives, the School Zone Blitz, specifically focused on enhancing safety in school zones. This initiative, along with our ongoing traffic education efforts, is helping to reduce risks and create safer roads for our children and the community at large.

# NEW IN 2024:

# **COMMUNITY RESPONSE TEAM (CRT)**

The Community Response Team (CRT) was launched as a forward-thinking initiative aimed at enhancing community outreach and addressing the complex challenges of unhoused encampments. This new program brought together dedicated professionals to foster a stronger, more connected community, with a focus on supporting vulnerable populations and improving livability for all residents. Staffed by Sergeant Nick Webster, and Officers Jaron McAlister and Brandon Bianchi, the CRT is committed to proactively engaging with the community through various outreach efforts and programs, building positive relationships with residents, local businesses, and service organizations.

The team is deeply involved in fostering community engagement through a wide array of programs. Notable events such as the Citizens' Academy provide residents with the opportunity to learn more about their local law enforcement, while programs like MAD-Kids Summer Camp offer a fun and educational experience for children. Events like Egg-stra Special, Halloween Spooktacular (National Night Out-Halloween Edition), Cookie with a Cop, Star of Hope, and the numerous Coffee with a Cop sessions provide positive informal spaces for the community to interact with officers, strengthening trust and communication. Additionally, the CRT supports the Neighborhood Watch and Business Watch programs, empowering community members to work together to create a safer, more vibrant environment.

Beyond these community-building efforts, the team is also dedicated to assisting the unhoused population by addressing the pressing issues of encampments and connecting individuals to the appropriate resources. By collaborating with local Madera County Behavioral Health services and facilitating access to housing opportunities, the CRT plays a crucial role in offering support to those experiencing homelessness. Their work is centered on compassion and solution-based approaches that aim to improve the lives of those affected, while also working to preserve the quality of life for the broader community. Through a holistic approach combining community outreach, direct support, and resource coordination, the CRT is making a meaningful impact in both the lives of individuals and the overall community.





# SHOWCASE:

### **CANINE "K9" PROGRAM**

The Madera Police Department has proudly maintained its Canine "K9" Program for several decades, emphasizing the crucial role these dogs play in supporting officers' everyday tasks. Currently, the department operates with three K9 units. These K9's live with their assigned officers, working alongside them each day to keep Madera safe.

The K9 teams undergo daily training, both at home and in the field, ensuring that their skills remain sharp and effective in serving the community. In addition to their daily routines, they participate in formal training sessions every two months to improve their proficiency and adaptability. Despite the intensity of their roles, our K9's bring a friendly and positive presence to the department.

Outside of their work, our K9's engage in community outreach, participating in school and public events to strengthen bonds with residents and fellow officers.

•Corporal Smith and Goose: Partners since 2020, Corporal Smith works with Goose, a six-year-old Malinois, specializing in apprehension and narcotic detection. They are part of the Patrol Division.

Officer Romias and Ulf: A three-and-a-half-year-old black Labrador, Ulf is trained for narcotic detection. Known for his focus and love of people, Ulf is a popular figure at community events. Officer Romias and Ulf have been a team since 2023, also assigned to the Patrol Division.

Officer Trinh and Bonnie: Bonnie, a four-year-old Golden Retriever, specializes in drug detection. Her energetic and affectionate nature makes her a hit with people, especially at school functions and public gatherings. Officer Trinh and Bonnie have been partners since 2023 in the Patrol Division.

These dedicated K9 teams exemplify the department's commitment to both public safety and building strong community ties.





#### SCHOOL RESOURCE OFFICERS

Officer Wayson Juarez, Officer Sandra Higareda, and Officer Ruben Hernandez are dedicated to serving the high schools and middle schools within the Madera Unified School District. These officers address any criminal issues that arise on campus during school hours and collaborate closely with MUSD security staff to ensure the safety and well-being of all students.





#### **HOUSING AUTHORITY OFFICER**

Officer Juan Gaona is assigned as the Housing Authority Officer for the Housing Authority of the City of Madera, where he provides dedicated police services to approximately 1,044 housing units throughout the city. His role involves ensuring the safety and security of residents, addressing any concerns that arise within the housing communities and fostering positive relationships.

## **CODE ENFORCEMENT**

Code Enforcement is dedicated to enhancing community beautification and development. The team addresses both residential and commercial property violations in accordance with the Madera Municipal Code, tackling issues such as public nuisance complaints, abandoned vehicles, vacant buildings, illegal dumping, and substandard housing. Code Enforcement works to identify violations and inform responsible parties, offering services and education to help them correct the issues.

Additionally, Code Enforcement supports community development by enforcing permit and license requirements across various city departments, including Business License, Building, Engineering, Planning, and Public Works.





The Madera Police Department takes great pride in the extensive training our officers undergo. Our training team works closely with the California Commission on Peace Officer Standards and Training (P.O.S.T.) to ensure our officers stay current and fully compliant with all state and local regulations. Officers participate in quarterly training, held every three months, which includes areas such as arrest and control tactics, firearms handling, less-lethal devices, de-escalation techniques, emergency driving, tactical communication, domestic violence response, and CPR.

We are committed to providing our officers with the most advanced and effective training available. Our goal is to surpass P.O.S.T. standards to ensure we deliver exceptional service to the residents of Madera.

Officers in specialized units or programs attend additional, targeted professional development training tailored to their specific roles. Examples of these units include S.W.A.T., Crisis Negotiation Team, Detectives, SIU, Traffic Officers, Parent Project, School Resource Officers, and Drone Pilots.

The health and wellness of our officers is also a top priority. To effectively serve the community, our officers must maintain both mental and physical well-being. This year, we expanded our Peer Support Team to six members, who provide critical assistance during both on-duty and off-duty situations. They offer guidance and help officers access stress management strategies, ensuring they thrive in both their professional and personal lives.

# MADERA COUNTY REGIONAL SWAT TEAM & CRISIS NEGOTIATION TEAM

The Madera County Regional S.W.A.T. team is a multi-agency unit comprised of sworn personnel from local law enforcement agencies in Madera County. It includes officers from the Madera Police Department, Madera County Sheriff's Office, and Chowchilla Police Department. Established in 2001, the team has since been dedicated to handling high-risk situations requiring specialized skills and equipment.

Team Composition: The Madera County Regional S.W.A.T. team consists of 21 members:

- 11 Deputies from the Madera County Sheriff's Office
- 8 Officers from the Madera Police Department
- 2 Officers from the Chowchilla Police Department

The team includes tactical operators, snipers, and tactical medics, all trained to handle a variety of high-stakes situations.

Mission & Operations: The S.W.A.T. team responds to incidents involving armed suspects, barricaded individuals, hostage rescues, and other situations requiring specialized operational skills. To ensure readiness, the team trains monthly in areas such as entry tactics, breaching, distraction device operations, precision rifle use, and the deployment of chemical munitions.

In addition to the S.W.A.T. team, the Crisis Negotiation Team (CNT) plays a key role in resolving

In addition to the S.W.A.T. team, the Crisis Negotiation Team (CNT) plays a key role in resolving high-risk incidents. The CNT is made up of members from both the Madera Police Department and Madera County Sheriff's Office. This team includes both sworn officers and professional staff who are specially trained in crisis intervention techniques.

CNT members are tasked with initiating constructive dialogue with individuals involved in suicidal, barricade, or hostage situations, aiming for a peaceful resolution. The CNT is also called to assist with pre-planned operations and high-risk warrant services.



# **EXPLORER PROGRAM**


The Explorer Program is designed for teens ages 14-21 who are interested in pursuing careers in the Criminal Justice System. Led by our dedicated officers, the program provides valuable mentorship and training. Corporal Kayla Bianchi serves as the lead advisor, with Officers Brian Rosas, Nathan Munoz, Ruben Hernandez, Jeremy Trinh, Salvador Zaragoza, and Brandon Bianchi assisting as advisors. Together, they teach explorers a wide range of law enforcement and life skills.

The group meets twice a month for training, which includes classroom instruction, hands-on scenario-based exercises, and physical fitness activities. Explorers also have the opportunity to participate in ride-alongs with officers to gain firsthand insight into daily law enforcement work. Additionally, they've assisted in undercover tobacco sting operations, ensuring local stores are not selling tobacco products to minors.

Throughout the year, the explorers volunteer at various community events, such as nonprofit fundraisers, school carnivals, MAD-Kids Summer Camp, the Egg-stra Special Event, Old Timer's Parade, Halloween Spooktacular, Christmas Parade, Pomegranate Festival, and the 4th of July Firework Spectacular, to name a few. The program's primary goal is to develop the youth of our community into future leaders, fostering lasting relationships built on trust and respect.

The Chaplain Program is a volunteer initiative that fosters a partnership between local faith leaders and the Madera Police Department. The Madera Police Department Volunteer Program is a vital resource that benefits both the City of Madera and its residents.
