Unknown Caller expressed that having Council having approval of all three item (D-3) is ideal. He expressed that cultivation vertical integration should be allowed in this area.

Councilmember Montes asked and City Attorney Montoy responded that the comments from Mr. Gogin would have been more appropriate to discuss in Item D-3. That is why she interrupted him because she knew he was talking about procedures as he'd sent an email with his concerns to the City Manager. Ms. Cantu Montoy suggested she can address questions and concerns once they are discussing that specific item (D-3), so that the items are kept separate.

Arianna Valdez expressed that non-local corporations are purchasing multiple properties thus making it difficult for locals to secure property for commercial cannabis use. She stated local applicants should be awarded points.

Akram Kassim stated local applicants should be awarded points. He also applicants the Council's decision to consider excluding Lions Town and Country Park from the distance requirement.

Rico Saldivar asked questions on equity requirements, marijuana convictions, and adjustments and was answered by the HdL consultant Mr. McPherson.

Angelina Garcia of Mainstream Medicinal Club expressed her thanks for moving forward and putting a price on the application. She thanked City Manager for all the answers he provided.

George De Leija of Team Mainstream expressed wanting points for local Madera residents.
