A member of the public asked if there were any smoke shops in the 144 applications that Mr. Rose said had been submitted. Mr. Rose stated he didn't have that information with him.

F. COUNCILMEMBER REPORTS/ANNOUNCEMENTS/FUTURE AGENDA ITEMS:

This portion of the meeting is reserved for the Mayor and Councilmembers (i) to make brief reports on boards, committees, and other public agencies, and at public events, (ii) to request updates, (iii) to initiate future agenda items., and (iv) to take action on matters initiated under this section of the agenda. Under this section the Council may take action only on items specifically agendized and which meet other requirements for action.

Councilmember Gallegos thanked the Safe and Clean Team that are working in the river. The residents have noticed the work being done. She also thanked Public Works staff for keeping the streets clean and picking up debris. The Police Officers and Firemen were also thanked for making sure we stay safe. She added that one of her students was recently in a house fire and they are well. Councilmember Gallegos thanked staff and stated that Council could not do their jobs without the rest of staff who serve the people of Madera.

Councilmember Rodriguez thanked staff and Councilmembers who attended the CTC (County Transportation Commission). They had a great turnout. He attended the self-help county coalition, Focus on the Future of 2023, regarding transportation. He asked for a future agenda item to assess our current public transportation. He has noticed that there is not a lot of ridership. He mentioned having "uber-type" transportation that would be able to take people to their appointments, etc. He asked if public transportation is being utilized in the best effective way. Councilmember Rodriguez asked if there is an ordinance on panhandling and if not, should they have something like the ordinance that doesn't allow smoking in the parks. Councilmember Rodriguez congratulated new Police Chief Chiaramonte.

Councilmember Montes thanked staff for their work. He thanked the Madera Islamic Center for the invitation to their Pray for Palestine event. He wants to be a partner for peace.

Councilmember Evans met with students at James Monroe Elementary at her "Crunch for Councilwoman" program. Students are complaining about the streets and she wants to make sure the children are safe. She mentioned that Breast Cancer Awareness Month had just finished and the NAACP (National Association for the Advancement of Colored People) had an awesome event where they recognized three people who dealt with this issue. Councilmember Evans stated that the Christmas Extravaganza is on December 17th and it would be great to see everyone there having a good time and bring toys, so that they can go out into the community and bless the children of Madera. They were able to give out 3,500 toys last year throughout the school district. She stated it would be great if Councilmembers could participate in giving out the toys. She is working on being able to give out bags of food to families. She also welcomed Police Chief Gino Chiaramonte.

Mayor Pro Tem Mejia mentioned that the Guelaguetza event was attended by people from Madera, Los Angeles, Santa Rosa and Milpitas. An estimated 5,000 people attended throughout the day. It was the first time having this event and it was a success. Videos of the event are on YouTube and the Police Department went viral in the Oaxacan news outlets. Organizers are very excited for next year. She congratulated Police Chief Chiaramonte and stated she attended his Oath of Office ceremony. Mayor Pro Tem Mejia mentioned that Washington Elementary held a "Calenda" for the first time. She met teachers from Oaxaca,

Mexico who are a part of an exchange program with Madera Unified School District. She thanked Councilmember Rodriguez for his attendance for the San Joaquin Water Summit in Visalia. It was part of the water education for Latino leaders and she was part of the organizing committee. She attended the Downtown Tour that took place on October 17th and she was also at the Islamic Center in Madera along with Mayor Garcia and Councilmember Gallegos and Montes. They were educated on the events happening in Palestine. She shared that they want a ceasefire and they want peace. Mayor Pro Tem Mejia mentioned the Dia de Los Muertos event that would be held tomorrow at Courthouse Park from 4:00 p.m. to 9:00 p.m. The purpose of the event is to try to bring authentic traditions to Madera for those who are not able to go to their homeland and to educate the community. They accept donations. They are not a non-profit. This is a group of residents that want to bring culture and arts to the City of Madera.

Councilmember Villegas mentioned that he submitted an application with the League of California Cities for the South San Joaquin Valley District Policy Committee and Environmental. There are about six to eight meetings a year. He thanked City Engineer Keith Helmuth for the information on crosswalks. He said there are several crosswalk issues in his district. He welcomed new Police Chief Chiaramonte.

Mayor Garcia stated that a Mexican delegation of fire fighters visited Fire Station 56 to thank the City of Madera and CalFire for their donation of fire fighting equipment. He recognized Domestic Violence Awareness and stated that education on this issue was supplied to residents. Mayor Garcia stated that there is more awareness of the Dia de los Muertos tradition. He invited everyone to attend the Veterans' Day event on November 11th at Courthouse Park. The event starts at 11:00 a.m.

Councilmember Gallegos thanked the Parks Department on the James Taubert Park event.
