# Background:

U.S. Transportation Secretary Anthony Foxx has announced \$500 million will be made available for transportation projects across the country under an eighth round of Transportation Investment Generating Economic Recovery (TIGER) competitive grant program.

TIGER discretionary grants will fund capital investments in surface transportation infrastructure and will be awarded on a competitive basis for projects that will have a significant impact on the nation, a metropolitan area or a region. The 2016 TIGER grant project will focus on capital projects that generate economic development and improve access to reliable, safe and affordable transportation for communities both urban and rural.

SR99 widening in Madera is on the National Freight Highway System is a significant project that fits the criteria outlined in the grant program. Without a doubt the most significant project in our region is the expansion of SR99. SR99 is not only a major thoroughfare for commuters through our county, it is also the backbone of the Central Valley's agriculture economy.

Subject: Support Madera Region SR 99 Widening Project

Dear Ms. Taylor:

On behalf of City of Madera, I am writing to express support for the regionally significant project in Madera County currently under consideration for TIGER program funding.

The City of Madera fully supports the Madera County Transportation Commission (MCTC) TIGER grant application for the State Route (SR) 99 Widening Project from Avenue 12 to Avenue 17. Federal funding for this project will assist in enhancing a vital freight corridor through California.

California, specifically the San Joaquin Valley, has been greatly affected by the potential deletion of \$754 million in funding for critical transportation improvements from the State Transportation Improvement Program (STIP). Current law required the California Transportation Commission to revise the Fund Estimate for the STIP due to lower forecasted state gas tax revenues. The revenues are decreasing because Californians are buying less gas due to fuel efficiency gains and cheaper prices (due to drop in price of gasoline).

The California Transportation Commission (CTC) has directed MCTC to delete \$2.7 million from the Regional Improvement Program (RIP) and Caltrans is also required to delete projects in the Interregional Improvement Program (IIP). The deletion of these funds would defund all STIP projects in the Madera region. MCTC Staff has worked diligently with Caltrans District 6 Staff to work on alternatives to meet the required STIP reduction by attempting to provide additional funding to one of the regional projects that has completed environmental clearance. MCTC has contributed an additional \$2.6 million in local transportation measure funds to the remaining STIP project on SR 99 from Avenue 12-17 replacing IIP funds.

The City of Madera recognizes that the San Joaquin Valley is a key contributor to agricultural goods and products to the nation. This project provides a major goods movement section for SR 99 through the City of Madera and is identified in the California Freight Plan.

As a regionally significant component of the national goods movement network, the widening of this section of SR 99 Project will provide the following benefits:

- Improve safety.
- Reduce congestion.
- Accommodate the traffic demand at or above LOS (Level of Service) 'D' by 2025.
- Improve the flow of goods and services for the region and the State, and provide the catalyst for regional and local generation of jobs.
- Leverage additional benefits from the State's investment on SR 99.

The Avenue 12 to Avenue 17 corridor is an anticipated major growth area for Madera County. There is planned residential, industrial and commercial development at the Avenue 12 interchange. Continued development of the State Center Community College campus east of SR 99 on Avenue 12 will generate additional regional scale travel.

There is also planned commercial development at the Avenue 17 interchange. The proposed sites of development are on both the west and east sides of SR 99. These projected development projects will provide employment opportunity benefits for the county.

Furthermore, the widening of SR 99 between Avenue 12 and Avenue 17 is consistent with the goals and intents of the Regional Transportation Plan for Madera County.

Thank you in advance for your consideration of this project application for TIGER program funding. We appreciate the opportunity to support the Madera County Transportation Commission in their efforts to complete this project.
